Related lawsuits for the accident were filed in the Superior Court in Riverside County, before Judge Gloria Connor Trask, and in Los Angeles County before Judge David L. Minning. Vicki Vitanza settled her claims following a mediation before Justice Robert Devich, Ret., at the Santa Ana, California offices of Judicate West. (See, Case No. RIC 398750, Riverside County Superior Court). The settlement resolves all claims of the Plaintiff. Regarding the settlement, Paoli stated, "We are satisfied that this settlement will fairly compensate Ms. Vitanza for her injuries and allow her to put her life in order and obtain future medical care."
